May 4, 2021

The Mower County Ditch Board of Commissioners in and for the County of Mower, Minnesota, met in Regular Session May 4, 2021 at 1:59 p.m. at the Government Center in Austin, Minnesota.

County Administrator/Board Clerk Trish Harren noted that nominations are now open for Chair. Are there any nominations for Chair? Commissioner Baldus nominated Polly Glynn. The Board Clerk called for further nominations two times. Hearing none, the Board Clerk asked for a motion to close nominations for Chair and to cast a unanimous ballot.

Motion made by Commissioner Baldus, seconded by Commissioner Ankeny, to close nominations and cast a unanimous ballot for Polly Glynn for Board Chair. Motion carried.

Chair Commissioner Glynn called for nominations for Vice-Chair. Commissioner Ankeny nominated Jerry Reinartz. Chair Glynn called for further nominations. Hearing none, Chair Glynn called for a motion to close nominations and cast a unanimous ballot.

Motion made by Commissioner Ankeny, seconded by Commissioner Baldus, to close nominations and cast a unanimous ballot for Commissioner Reinartz as Vice-Chair. Motion carried.

Cody Fox requested an increase in the annual budget for expenditures related to Ditch #4 because the pipe repair costs were more expensive than anticipated due to increases in the costs of materials.

Motion made by Commissioner Ankeny, seconded by Commissioner Baldus, to amend the 2021 budget to increase the annual expenditures for Ditch #4 from \$11,167 to \$35,000 for a tile pipe repair. Motion carried.

Motion made by Commissioner Mueller, seconded by Commissioner Reinartz, to approve the minutes of May 4, 2021 subject to review and approval of the chair. Motion carried.

Motion made by Commissioner Ankeny, seconded by Commissioner Reinartz, to adjourn the meeting at 2:06 p.m. Motion carried.
