ORDINANCE AMENDMENTS:

- Land Use Zoning Cannabis – Article VIII – an ordinance which incorporates portions of the Cannabis Ordinance into land use regulations, as adopted by the Mower County Board of Commissioners December 17, 2024.
- Large Event Ordinance – Article IX – an ordinance which regulates the operation, responsibilities, and management of large special events within Mower County, (outside of municipal boundaries) to protect the health, safety and general welfare of citizens and partakers. Ordinance includes **exemption** for government sponsored events; municipal celebrations; county fairs; private gatherings such as weddings, funerals, graduations, reunions; garage sales, auctions, farmer's markets, church, and fraternal events.
- Section 14-18.7 SPECIAL REQUIREMENTS FOR SOLAR FARMS AND GARDENS Underground Electrical Lines; depth standards
